# 1. EXECUTIVE SUMMARY

## 1.1 INTRODUCTION

As a result of continuous hard work and prolonged efforts of the people belonging to the local region this college was taken over by the Govt. of Haryana on 17th May 2005 and was named as Shaheed Udham Singh Govt. College thereafter. This college is continuously moving towards the path of success since its inception and has completed 25 Years of its academic achievements. Despite limited number of available resources, this college has proved itself as an ideal institution for its students. There are faculties of Science, Arts, Commerce catering to the needs of both boys and girls of local region. Various subjects like Hindi, English, Economics, Physical Education, Pol. Science, History, Music, Geography, Psychology and Math's are being taught here under Arts faculty. The aim of this college is overall development of personality of the students along with their mental and academic growth so as to enable them to lead a successful life ahead. The students are motivated to decide their career keeping in view their individual talent and particular interests. Affiliated to KUK, this college is situated in a lush green environment far from the madding crowd of cities on the Matak-Majri-Indergarh Road surrounded by natural greenery. There are neat and clean lecture rooms, smart laboratories and computer labs too which are well equipped for study purpose of students. Three computer labs are there to impart Computer Education to students based on latest technology. The college also boasts of a large playground, Multipurpose Gymnasium Hall and is having all equipments related to the same. ### **Institutional Strength**

S.U.S. Government College Matak Majri (Indri) is maintaining good traditions in academics and other activities and providing all necessary facilities in a supportive study environment for ensuring quality higher education to students.

In studies the outcome based systematic learning is provided by scholarly and dedicated teachers with the broad based objectives of providing the best possible subject knowledge, an exposure to cross cutting socio-cultural & politico-economic issues, an environment to develop critical thinking & analytical skills, a deep grounding in value system and ethics, a continuous graduation in discipline, an unstressed gradual learning and an easy accessibility of education to all sections of the society. The transparent and student friendly continuous Internal Evaluation system add to the effectiveness of studies in the college.

The wide range co-curricular/extra-curricular and extension activities are conducted by different designated cells, namely NSS, NCC, Women Cell, Legal Literacy Cell, Placement Cell and Subject societies. The leadership role given to students in organizing these activities and their enthusiastic participation in them are noteworthy mode for ensuring their holistic development. The spirit of social work and dignity of labor imbued through these activities will help them in their career growth. There are appreciable achievements of college students in cultural and sports competitions at university, state and national levels.

The fully airy and ventilated classrooms and laboratories. The availability of various computer labs and other ICT facilities, a large multipurpose sports ground in addition to grounds for other sports, a well equipped Conference-cum-activity room and Canteen are some of the mentionable infrastructural facilities provided by the college.

The practice of transparent and affordable cost effective higher education, the facility of scholarship to the SC and BC and meritorious IQAC cell, the Alumni Association, the disable friendly campus, the sustainable environment related initiatives are among the mentionable strength of college functioning.

### **Institutional Weakness**

S.U.S. Government College, Matak Majri (Indri) is providing good services in the field of higher education but there are some issues which need to be addressed to follow the parameters as envisaged by assessment and accreditation agencies.

The college is affiliated institution and it has to strictly abide by the rules of the affiliating university. This reduces the scope of changes in accordance with the requirement of students and needs of time. The process

to get these changes affected is procedurally circuitous and the alternations so made might not be whole some.

The research is an area where some measures have to be initiated and the rules of affiliating university for granting permission to involve more college teachers to work as research guide. No major grant for research has been sanctioned and it is basically dependent on the individual initiative of the teachers.

Despite the active involvement of different designated cells of the college with other agencies, the scope to enter into formal MoUs and collaborative efforts is limited in the absence of enabling rules and the ready availability of accessible institutions/agencies.

The frequent transfer and deputation of teaching and non teaching staff to other colleges and putting college staff on duties other than college activities might affect at times,, the stability of academic activities.

The placement is another area which needs some thought as the students after graduation do not get the dignified job with higher salary unless they have some higher degree or experience. Even the post graduate students have to take a break after their degree for preparing for NET examination. Moreover, the data availability on the career/academic progression of students is meager and cannot be full proof as students after passing from the institution are busy in their future growth and do not remain with institution.

### **Institutional Opportunity**

S.U.S.Government College Matak Majri (Indri) is earnestly working for providing affordable and accessible quality higher education to common masses. It is committed to ensure inclusive growth of all students and provide them broad based education with a wide range of academic co-curricular and extra-curricular activities. The institution is trying to tap the following opportunities for the benefits of the students and the society:

- \* Catering to students from surrounding rural areas and providing them an easy access to quality higher education in their near vicinity.

However the college is working earnestly under the given conditions for providing the best possible quality education to students.

## **1.3 CRITERIA WISE SUMMARY**

### **Curricular Aspects**

#### **: Criterion 1**

### **Curricular Planning and Implementation**

The institution being an affiliated college of Kurukshetra university, the authority and prerogative to design the curricula lies with the university only. However, occasionally selective faculty members get an opportunity to be a part of the board of studies and contribute in curriculum design as well. The university has implemented NEP 2020 and adopted CBCS w.e.f. 2020-21. Course outcomes and the Program Outcomes are well-defined in the curricula and it is the responsibility of the institution to make it sure that the expected outcomes are achieved which is the prime focus of the examination committee in particular and all the faculty members in general.

### **Academic Flexibility**

The institution offers graduation programs in the broad faculties of Physical Sciences, Biological Sciences, Computer Sciences, Commerce and Arts and Post-graduation programs in English, History and Commerce. Around 39 percent undergraduate students earned certificates through language lab course and Compulsory computer education course during the assessment period. Apart from that, selected students join NCC to earn B certificate/ C certificate while some selected students join NSS to receive NSS Volunteer Certificate. With implementation of NEP 2020, Skill Enhancement Course, Ability Enhancement Course, Multi-disciplinary Course and Value-Added courses have also become an integral part of college education.

### **Curriculum Enrichment**

Structure and curricula of the programs are so thoughtfully designed to enrich the personality of the students. Some courses focus on developing human values while some others in inculcating life skills, some courses prepare students to meet the professional challenges while some courses motivate them for personal and societal growth but one thing is sure that each and every course as a part of the program, adds enrichment to the experiences of the students

### **Feedback System**

Feedback Mechanism of the institute is quite transparent. Links are provided on the college website, separately for the students, parents and alumni. The feedback automatically gets analysed and is available to DGHE, Haryana for review and action too. However, at institute level, it is tried to collect and analyze the feedback and thoughtfully address the concerns of the students at earliest possible

During the 5 years of assessment period, only funds worth only 1.81 lakhs have been mobilized for research and only 1 faculty member have got the benefit. Obviously, this is the area, the institution needs to work upon very seriously.

The institution offers a conducive environment for innovations. The convenor of Placement Cell is supposed to organize activities that develop innovative ideas and motivate and lead the student to bright careers. 5 workshops/ conferences were organized by the college during the assessment period.

96 papers and 24 books/book chapters were written by the college faculty during the assessment period which comes down to 1.64 publication/ faculty member and 0.43 books/book chapters.

## **Infrastructure and Learning Resources**

### **Summary: Criterion 4**

#### **Physical Facilities**

The institution boasts of a spacious campus spread over 11.36 acres with built in area of 4354.33 sq. m. with 18 spacious rooms and 10 well equipped labs across three teaching blocks. Language lab, computer labs, subject specific labs, multipurpose sports ground, gym, swimming pool, seminar hall cater to the need of holistic education and personality development of the students. College has 3 functional internet connections to facilitate IT facilities to every student and every faculty member. On an average, 87.96 percent is spent on infrastructure development and augmentation

## **Student Support and Progression**

### **Summary: Criterion 5**

#### **Student Support**

College offers BC scholarship, SC scholarship, Merit Scholarship to the students. During the assessment period, 47.47 percent of the students got benefitted by various scholarship schemes. Placement cell of the college strives hard to conduct various activities throughout the year to get the students due guidance to make them ready for appointment.

#### **Student Progression**

44.89 percent of the outgoing students have progressed to higher education during the assessment period. Many of the students have got appointments too but record is not available.

#### **Student Participation and Activities**

Students are provided with ample opportunities to showcase their talent in various fields through various activities organized in the college throughout the year. On an average 8-9 sports/cultural activities are organized every year. 19 medals/awards have been bagged by the college students in sports/ cultural activities during the assessment period.

College has a registered Alumni Association and Alumni Meet is conducted every year. Alumni feedback is collected, analysed and considered for improvement of the college.

This college being a Government of Haryana institution, liberal funding is provided by the Department of Higher Education, Haryana through grants and the grants are optimally utilised for the benefit of the students strictly as per the Government guidelines.

### **Internal Quality Assurance System**

College has a well structured IQAC constituted as per the NAAC guidelines. Regular meetings of IQAC are held to ensure that good standards of education are maintained in the college. All the aspects of education are discussed thoroughly and plans & strategies are made to improvise and keep improvising. IQAC monitors the progress throughout the year.

**Response:**

The college is a premier higher education institution of Government of Haryana having a large campus of about 11.36 acres with the covered area of approximately 4354.33 square meters. There is adequate facility of classrooms and laboratories for fulfilling teaching-learning needs. There are three teaching blocks viz. Arts, Commerce and Science with seventeen class rooms. The different size classrooms are quite adequate to accommodate the students as per the requirements of classes. All rooms are airy and spacious to provide healthy and hygienic study conditions. They have requisite number of dual desks or sitting chairs and have the facility of white or black board. Moreover, the work on constructing a block for library, canteen and international swimming pool is in process.

There is a good infrastructure of laboratories in the college and there are separate labs in each teaching department in which practical is the part of the prescribed syllabus. These labs are well equipped with necessary experimental facilities and are upgraded annually by grant received from the government. These labs are the key to impart learning to students by experimentation and thus to provide them an exposure of simulated practical conditions. There is a separate infrastructure of computer labs in the college for ensuring the optimum interface of teachers and students with ICT which is the need of the hour. 5 well equipped committed computer labs are maintained by the college for providing basic computer education to all those first year students in whose regular syllabus computer is not included. There are many other separate computer labs for providing committed ICT facility for different courses. The well equipped Computer Science Labs caters to science undergraduates in Computer Science and Computer Application programmes with computer language wherewithal. The college English Language Lab becomes handy in teaching students basics of language abilities, pronunciation and other linguistic aspects. There is a college library having the support of leased line and Wi-Fi for speed and ready access of internet facilities. The teachers have easy access to ICT facility and they can use it for academic and research purposes. Not only this, some departments and cells are well equipped with the facility of computers and printers for teaching and other duties.

There are good facilities for organizing cultural activities and sports events in the college and students enthusiastically participate in these activities. There are separate Music Departments for vocal and instrumental events and they cater not only for teaching students the subject of music but also for arranging performances during different functions and competitions.

There is a large sports ground of about 3.5 acres approximately in the college for organizing sports events. The multipurpose sports ground is regularly used for practice by students and for organizing many sports competitions and activities. Besides this, the sport ground has provision for 200

meter athlete track, football, basketball, volleyball, badminton and kho-kho, wrestling & boxing practice and organization of the related sports events. College gym facility is equipped with latest gadgets for the physical fitness of students.

## 6.3 Faculty Empowerment Strategies

The case is forwarded to the Director General Higher Education, Haryana for final approval. The Non-teaching Staff members are assessed through the Annual Confidential Report (ACR). The Principal is the competent authority to determine the grade of the employee on the basis of duties performed, timely completion of work and capacity to work in a team, integrity of the employee and relation with the chair etc.

Further, as per the Government of Haryana, the following facilities are available to all permanent staff of the college:

1. Medical Reimbursement for various illnesses.
2. Group insurance scheme for all employees.
3. Faculty appointments prior to 2006 are eligible for pension benefits on retirement. Faculty after 2006 are covered under New Pension Scheme.
4. Child education allowance.
5. Fixed Medical allowance.
6. LTC as per Government of Haryana rules.
7. GPF advances and loans as per Government of Haryana rules.
8. Leave to teaching and non-teaching staff are given as per the guidelines of KUK and UGC.
9. Festival advance and house building loans facility is also available as per Government guidelines.
10. Staff can take various loan(car, house, computer etc) as per Government of Haryana norms at subsidized rates.
11. Residential Quarters are provided on campus for teaching and non-teaching staff. various scholarship provided by the central and state government

12. Various scholarships provided by the central and state government.

There are different sources of fund mobilization and the college strictly follows governmental norms in resource mobilization. The government grants are the major source of financial resources. These are sanctioned for different purposes by the parent Department of Higher Education, Haryana such as the salary of the staff, the conduct of various co-curricular/extra-curricular activities, the up-gradation of infrastructural and laboratory facilities, the purchase of library books, the maintenance and enhancement of ICT facilities, the addition of new infrastructure and other related activities. The budget is allocated in accordance with the requirements of the college and broader policy parameters of Government of Haryana.

In addition to this, the college receives fees and funds from students and these funds are used for earmarked activities related to students' teaching-learning, co-curricular/ extra-curricular and other activities. Different works for students' welfare and improvement of college facilities are accomplished through the amount received in this manner. The college administration ensures that the mobilized financial resources should be optimally used for the desired purpose without any pilferage and in mobilizing resources other than government grants but also its proper utilization for providing better facilities to students and staff.

Institution conducts internal and external audits regularly. The college has a well-defined policy for internal and external audit. Internal audit is conducted occasionally by the Principal, Bursar and IQAC and being a Govt. institution, external audit is the prerogative of the DHE, Haryana
